

## Procedure and conditions for conducting the licensed integrated exam "Krok 2. Medicine" in 2020

*composed according to the Temporary regulations for organization of anti-epidemic measures during the certification of students in the field of knowledge "22 Health" during the quarantine period in connection with the spread of coronavirus disease (COVID-19), approved by the Resolution of the Chief State Sanitary Doctor of Ukraine from 28.05.2020 No 29*

*and in pursuance of the Order of the Rector of Danylo Halysky Lviv National Medical University dated 28.05.2020 № 1198-z*

## VI. Examination Procedure

1. Passport availability for the studentt **is obligatory**.
2. Admission to the building and the examination participation is allowed only in protective masks or respirators. Respirators can be used throughout testing. Protective masks should be changed at least once every 3 hours or if the mask is dirty / wet.
3. The admission of accompanying persons to the building of higher education institution is forbidden, excepting those who accompanying students or interns with disabilities.
4. All students at the entrance to the building undergo temperature screening which allow detecting the presence of respiratory diseases indications.
5. Students who have a body temperature above 37.2 ° C or the respiratory diseases indications (fever, runny nose, cough, shortness of breath, etc.) are not allowed to take the exam, which is certified with the relevant act.
6. 6. If the student's body temperature does not exceed 37.2 ° C, but he has the respiratory diseases indications (fever, runny nose, cough, shortness of breath, etc.), such student is not allowed to take the exam.
7. There is an organized place for hands treating with antiseptic at the entrance to the building, the place is marked with a bright indicator.
8. Applicants, who have undergone temperature screening, are wending to the audience. The seating places for applicants are marked with colored stickers in order to maintain a distance between them of at least 1.5 meters.
9. Before entering the audience, it is recommended to visit the bathroom for hands washing, and at once wend to the audience.
10. At the entrance to the audience, the student leaves his personal items in a specially designated place. The student keeps only passport, pen, personal protective stuff (sanitizer or hand antiseptic, spare disposable masks or respirator).
11. Each student must have one or two pens with deep black ink.
12. Before and during the exams the keeping distance between students of at least 1.5 m is obligatory.
