2. Short annotation to the course

Discipline "Health protection organization, including the work of the dental service" provides mastering of:

• *health care organization* – the activity of system to provide preservation, strengthening and restoration of health of various public groups, particularly organization of dental care;

• *the basics of economic knowledge in the health care system*, necessary to assess the economic feasibility of public health decision-making.

3. The purpose and objectives of the discipline

1. The purpose: to master necessary knowledge and skills and gain competence in terms of examining, analysis and evaluation of public health indexes, organization, resource supply and functioning of the health care system, recommendations on preventing and elimination of harmful effect of factors and improvement of organization of medical care to the public, particularly dental care.

2. The main tasks:

• mastering the basics of the organization of medical care, the principles of assessing the organization and quality of dental care to the population, including during emergencies (pandemics, martial law);

• mastering the principles of developing measures to preserve and strengthen the health of the population and its individual contingents;

• mastering the theoretical foundations, modern principles, patterns, economic principles and strategic directions of public health;

• formation of practical skills in the use of methods of planning, organizing and evaluating the activities of health care institutions and individual practitioners;

• mastering the basics of financial management in health care, studying indicators of financial stability and efficiency of use of funds.

- contributes to the formation of economic worldview and basic competency characteristics for the methodology of economic analysis of medical institutions in modern conditions.
